After some discussion the present Directors of the Coalition were empowered to act as temporary Board Members of the new corporation.

The subject of dues was taken up and it seemed that \$5.00/yr. for an individual member and \$25.00/yr for an organizational member would be adequate provided other necessary financing means could be found. When the subject of a rummage sale/raffle was discussed I suggested that we hold it in conjunction with a flying circus put on by the Valley Flyers, advertise it as such and use the field as a locale. This suggestion was greatly acceptable and a committee, of which I'm a member, was delegated to firm up the details.

This operation will require that the club endorse the actions of The Coalition to Save the Basin relative to the placement in the Basin of Olympic facilities or other facilities not in line with the original purpose of the Basin. I shall make a motion at the next meeting to bring it to a vote of our members to determine the club's attitude.

There wasn't as many geared glow engins (maximizers and the like) as I had thought there would be. Most of geared jobs were on the Byron 1/3 scale Pitts. Although a number of the Pitts used direct drive engines of various makes and styles. The workmanship and detail of some of the models was fantastic, but the size of the models makes it somewhat easier to put scale details in.




All in all it was a well organized meet and I personally think Ed Morgan, Lee Taylor and the rest did a Hell of a Good Job.

Ham's Eggs Griddled. Rated R (rough language, some nudity, gore).

Huzzahs to Robert Greenford for his amazing portrayal of Hambone Jerkman, chief of staff to the President of the United States in this stark, raw film of Washington intrigue.

Jerkman, constantly trying to overcome a serious speech impediment (he can't keep from calling himself Jorkman), is seen early as a brilliant backwater lawyer defending his peanut-farmer client in a suit brought by the mighty Unspreadable Peanut Company. The client, a toothy oaf named Cartwrong Jimmeson ("Jes call me Jimme.") has been accused of substituting watermelon seeds for peanuts and causing a nationwide epidemic of diarrhea. Jerkman fails in having the charges watered down but becomes fast friends with Jimmeson, who rides his notoriety to election as county dog catcher, then President

Here, just as the movie should gain power and attention, it falters. First, it's discovered that Jimmeson's half-sister is the power behind a porno publishing house. She is saved—we're never told how or why—by a found-and-lost-and-found again sun worshipper named Moon. When it seems that the half-sister is about to be fleshed out as a major character she is dispatched by a run-away beer truck. The truck, it turns out, belongs to a brewery owned by the President's brother, Slobman Jimmeson. Is this political assassination? Expediency, to save Cartwrong from the clutches of Moon? Who knows?

Instead, the convoluted plot switches to the President's precedious, myopic daughter, Sissy Sue. Sissy Sue is constantly beset upon by her classmates, who take great delight in shooting spitballs at her thick glasses. To counteract this outrageous behavior, Sissy Sue gets contact lenses. However, while wetting one down for insertion, she swallows it

It's at this point that Hambone re-enters the movie. He has been, we find out through a flashback, weathering the vicious attacks of a raffish liberal senator called John Dynan. Among other things, Dynan accuses Ham of expectorating in restaurants, picking his nose in public, not wearing underwear,

and sniffing bicycle tire treads in a swank New York disco. But as Dynan is about to fry Ham, Ham learns that Dynan has been seduced by the daughter of the jury foreman that found the President guilty in his messy diarrhea suit. In a heart-wrenching scene, Ham rats on Dynan to two investigative Washington reporters who succeed in having Dynan recalled.

So ... Hambone re-joins the movie just as Sissy Sue swallows her contact lens. In a scene of mesmerizing power, Hambone dies from the blow, Sissy Sue dies from the pounding, Toady dies from a heart attack, and Slobman dies from an alcoholic seizure. Upset, the President goes on vacation

To soothe his aching heart, Cartwrong sneaks away from the Secret Service and goes electric eel fishing on the Susquehanna River near the Seven Acre nuclear facility. The plant has been leaking vast quantities of radioactive waste water into the river, but the utility's managers disclaim the charges and raise electric rates 600 per cent—with the President's consent.

Now, hold onto your seats—the President's canoe is savagely attacked by a giant mutant beaver. Cartwrong thrashes at the monster with his paddle but the beast eats it. Slowly, while the President valiantly defends himself with a beer can tab, the creature-spat-from-hell devours the canoe. The final scene, not for those with weak stomachs, shows President Cartwrong Jimmeson disappearing into the gaping jaws of the beaver. Before we're shown the unspeakable, the camera picks up ex-President Ricardo Wilmouse Dixon being sworn in as the new President.


